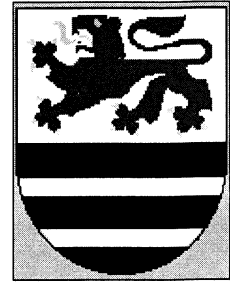

## Power of Attorney

The power of attorney is given for all legal acts to the  
Trustee Mrs. Esther I Munu-Lakoh from Helmut F Giesa,  
in conjunction with the recovery of the loan, the loss and damages, lawyers fee of the  
**Loan Agreement / Breach of Contracts** and extra claims for the cost incurred in asserting  
the legal rights to defend the “fraudulent **counter-Lease-claim**” of Mr. Watfa.

The Loan/Credit and “Lease Case” are dealt with the  
law chamber TANNER Legal Advisory (TLA).

Mrs. Munu-Lakoh is additionally allowed to negotiate any necessary actions to be taken  
to recover the money, e.g. sue a file, initiate liquidation, and confiscations, and others.

She agrees to synchronize all necessary steps with Mr. Helmut F Giesa via e-mail.

All received monies / cheques will be paid into ECO / Procredit bank account (Freetown)  
of Mr. Helmut F Giesa.

In Principle the debtor is obliged to send all monies to the GuB Bank Account in Germany.

This “single” power of attorney is granted for three persons:

of the Non-Citizen Registration Immigration & Expulsion Act No 14 of 1965*

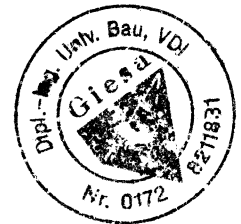
